## Board of Directors' Report

Your Board has been busy this spring, meeting with City and Borough of Juneau (CBJ) officials to ask how the League can better assist the CBJ. To date, we have met with CBJ City Manager, Kim Kiefer, Mayor Merrill Sanford, and Assembly Member Mary Becker. A repeated theme at these meetings was the concern that all had about the low voter turnout for municipal elections as well as the lack of candidates.

Kim suggested that the League work with a low-turnout precinct and develop a program to increase voter education and turnout.

Mayor Sanford reminded us that when the municipal election turnout is only 30%, this means that measures are passed and candidates are elected by only slightly more than 15% of eligible voters.

Mary Becker reported that more citizens need to apply for positions on the 19 advisory boards that assist the CBJ Assembly. She also mentioned the collaboration recently re-established with Haines and Skagway to work on issues of importance to northern Southeast.

The next Juneau League Board meeting will be held on July 20<sup>th</sup>, and Assembly Member Randy Wanamaker will be attending. All Juneau League members are invited to attend. Randy's visit will last from 10-11 am at the Catholic Community Service conference room, followed by the monthly Board business meeting. All of our meetings are open to the public and our members are always welcome.

We hope to see some of you there!

## Updating the Juneau League's Position on CBJ Advisory Committees

Many of the League of Women Voters Juneau positions have not been updated in several years and may be out of date. One of the League's goals this year is to update its position on Advisory Committees, which was effective November 1984 and has been reaffirmed each annual meeting. Is it still relevant? Can it be effectively used to advocate for improvements to the City and Borough of Juneau's advisory committees' process? There are several types of advisory committees, i.e. Advisory Boards (19), Appeal Boards (6), Boards Established by Charter (6 Enterprise & Special Boards) and Ad Hoc Committees/Task Forces and Boards Appointed by Others (5). Over the past six months, the study committee of Ruth Danner, Margo Waring and Cheryl Jebe have reviewed the current position, sought input from the City and Borough Clerk, Laurie Sica, and discussed language changes. The committee asked the Juneau League Board of Directors to review its work to date and consider draft recommended changes to the November 1984 position and possible further study parameters, if necessary. After review of the current position and discussion of the proposed changes, the Board agreed the position is still relevant and tweaked the new draft language.

**The Board decided to put out the following draft for member review and comments.** It is possible the Board may adopt this draft as the updated position at its July 20, 2013 Board meeting. As always, all members are invited to attend this Board meeting. **Update to Position: Advisory Committees [*November 1984*]**

**Brackets and words italicized are deletions;  
CAPITALIZED WORDS ARE NEW WORDING.**

The Juneau League of Women Voters supports the use of advisory committees by the Assembly of the City and Borough of Juneau (CBJ). We believe that citizen committees can provide a valuable means of participation in government. In order for these committees to be effective, the resolution establishing the committee should clearly state the mission and scope of activities. **THESE MISSIONS CAN BE FOUND ON THE CBJ WEBSITE.**

**"ADVISORY COMMITTEE" IS DEFINED AS A COMMITTEE, BOARD, COMMISSION OR TASK FORCE OF CITIZENS TO ADDRESS SPECIFIC COMMUNITY ISSUES OR NEEDS AND WHICH CONTAINS NO CBJ ASSEMBLY MEMBERS AS VOTING MEMBERS.**

Advisory committees should serve as channels for public opinion on specific, detailed issues related to the work of the Assembly. Therefore, each committee should be related to a specific subcommittee of the Assembly or the Assembly as a whole, and should report to *[it]* THE ASSEMBLY on a regular basis, **BUT AT LEAST ANNUALLY AND IN WRITING AND THE**

REPORT(S) PUBLISHED ON THE COMMITTEE'S WEBPAGE. [*The frequency of this reporting will vary with the mission of the committee; semi-annual reporting would be an acceptable minimum.*] COMMITTEES SHOULD BE ENCOURAGED TO SCHEDULE A PRESENTATION TO THE ASSEMBLY'S COMMITTEE OF THE WHOLE ON ISSUES FELT TO REQUIRE SPECIAL ATTENTION.

In addition to reporting to its guiding Assembly subcommittee, the activities of each committee should be reviewed annually by the entire Assembly. At that time, the committee should be given further guidance by the Assembly, or should be suspended, or dissolved, as the need warrants.

Committee membership should be balanced to represent the interests which will be served by its activities. In some cases, a balance between technical expertise and affected user groups should be emphasized. In other cases, a balance of age, sex, race or other factors would be more important.

When filling vacancies on a committee, the Assembly should publicly advertise the opening. A standardized application form should be used to determine the applicant's reasons for wishing to serve on the board and qualifications that would contribute to the committee's mission and balanced composition.

While appointing members with conflicts of interest arising from the work of the committee is not desirable, excluding individuals who have occasional conflicts may not be practical without limiting the technical expertise required by some committees. All members of advisory committees should receive an initial IN PERSON OR WEB BASED orientation IN ADDITION TO THE CBJ'S ON-LINE MANUAL AT [HTTP://WWW.JUNEAU.ORG/CLERK/BOARDS/DOCUMENTS/2011-05-25\\_BOARD\\_INFO\\_PAMPHLET-VERSION\\_2011-02.PDF](http://WWW.JUNEAU.ORG/CLERK/BOARDS/DOCUMENTS/2011-05-25_BOARD_INFO_PAMPHLET-VERSION_2011-02.PDF) (OR ITS REVISED EDITION) that includes recognizing and handling conflicts of interest according to the Charter of the City and Borough.

In keeping with principles of citizen participation in government, all meetings of advisory committees should be open to the public. Meetings should be held on a regular, scheduled basis, with published agenda and adequate public notice of the time and place of meeting. PUBLIC TESTIMONY TIME SHOULD BE AVAILABE AT EACH MEETING OF THE COMMITTEE. A WRITTEN RECORD OF EACH MEETING OF THE COMMITTEE TO SUMMARIZE THE MEETING AND ANY DECISIONS MADE SHOULD BE TAKEN. This written record should be filed in the City Clerk's office PROMPTLY following each meeting and should be available to the public, AND INCLUDED ON THE CBJ WEBSITE. [*Formal public testimony need not be taken at all meetings of the committee, but should occur frequently. Some written record of each meeting of the committee should be made. Formal minutes are not always necessary. A summary report of the meeting and the decisions made could be an adequate substitute.*]

Support services should be provided to facilitate the work of the boards and to provide continuity in their activities. Each committee should be assigned a staff person to help coordinate its activities and to provide access to clerical support.

Standard by-laws should be provided to each committee at its inception. These by-laws could be modified and adopted by the committee to meet its own particular needs. A central file should be maintained in the office of the City Clerk containing individual files on each of the boards and committees including the following materials: the resolution or ordinance creating the committee, the by-laws adopted by the committee, the current and historic membership of the committee, and all AGENDAS, MINUTES AND reports filed by the committee. All these materials should be available to interested citizens on request AND ON THE CBJ WEBSITE.
