Proposed Bylaws Changes

The LWVUS is encouraging Local Leagues to convert from 501(c)4 status to 501(c)3. At the LWVUS Convention in 2016, a pro-bono lawyer did several workshops on the subject and offered pro-bono help to local LWVs. LWVJ Board member, Pat Watt, attended the workshop and has been leading the work to determine if our League should do this conversion.

Note that, evidently, the initial 501(c)4 status for new LWVs was originally chosen out of what the LWVUS now says was an unnecessarily cautious interpretation of how much "lobbying" local and state Leagues actually do. Several state LWVs, and the local LWVs in those states, have already done the conversion to 501(c)3. The LWVJ Board has discussed making this change, decided it is the right thing for us to do, and has retained the pro-bono assistance of Beth Chapman (with Faulkner Banfield PC). Also, Elgee Rehfeld has indicated they would be willing to provide whatever pro-bono accounting help we need.

Advantages of converting to 501(c)3:

- All donations would be tax-deductible to the donors including membership dues;
- It would dramatically reduce the workload for us to get at the funds in our Ed Fund account now held with the state League;
- It would reduce the workload for the state League in that it wouldn't have to maintain an Ed Fund account for us;
- As a 501(c)3 organizations we would have to review our accounting records periodically (a good thing);
- We would be eligible to apply for foundation and other grants;
- It would have no effect on our advocacy work (the perception that 501(c)3 organizations are strictly limited in their advocacy work is mostly incorrect.)

Disadvantages

- The conversion process is lengthy; (Although we have already completed the bulk of the work)
- We would have to amend our bylaws to comply with Alaska requirements for incorporated nonprofits, and to comply with IRS requirements for 501(c)3s. (Up for approval)
- We would have to file an annual Form 990 with the IRS however, since our gross receipts are less than \$50,000, only the simple 990-N postcard is required (failure to do so by the deadline automatically revokes the exemption); (Treasurer responsibility)
- We would have to file a Biennial Report every 2 years with the state Division of Corporations (\$25 fee) in order to remain in Good Standing:
- We would have to send receipts for all donations. (Hopefully, we do that anyway.)

The first step in the conversion from 501(c)4 to 501(c)3 is to amend our bylaws to conform with legal requirements of the state and the IRS. Our Bylaws Committee (Mary Borthwick, Cheryl Jebe, Chris Niemi, and Pat Watt) have prepared proposed amendments in the attached documents. These amendments will be presented to the membership for action at the Annual Meeting on March 25.
