 9:37 AM Call to Order: Marianne Mills Introductions and welcome members C. Niemi and M. Menzi.
Present: F. Compton, G. Brown, P. Watt, G. DelRosario, H. Barthel, J. Andree, C. Jebe, M. Mills.

Approval of Agenda: Motion by G. Brown, G. Del Rosario second – no objections

Approval of November Minutes: Motion by C. Jebe to approve as amended with unanimous consent.

Treasurer's Report: Balance of \$7,393.26 all accounts.

G. Brown Motion with G. Del Rosario second to pay J. Lyon \$45.50 for 11/20/14 membership/orientation meeting's room charge at Thunder Mtn. No objection, Motion passed.

President's Report: Membership meeting/orientation "Pizza and Politics" was very nice. Special thanks to J. Lyon, A. Currey, H. Barthel, F. Compton, and speakers at the meeting, M. Menzi and B. Smith. M. Mills will follow up with guest N. Lefebvre. M. Mills requested a volunteer to prepare a spreadsheet with LWV Juneau's member's interest. J. Andree volunteered to prepare.

Thank you C. Niemi, H. Barthel, and G. Del Rosario for organizing the Legislative Reception. Recommend having future meetings at a home, less expensive, easier to hear. Request F. Compton send thank you to Cathy Munoz.

Special Report on Juneau School Board - M. Menzi: She is a community member of Juneau School Board's social studies curriculum review. She presented her in-depth report for Civics curriculum review (her background is in Dept. of Education, social sciences). She recommended:

- More in depth and challenging curriculum very little time spent on this subject;
- Current events discussed at each grade level (You tube video University of Texas campus asking students general civics questions vs today's Hollywood);
- Experiential civic education and programs i.e.; classroom election, kids voting, mock elections, trials, legislative hearings, youth courts, use of Gavel to Gavel, attending CBJ meetings, internships.

Juneau's School District is planning to cut back on Social Studies. There is no time allocation given to teachers for this subject. There is an opportunity for League to voice support to the Civics portion to the School Board and support for this committee.

P. Watt: We can do an action alert to members and friends. We could Facebook publicize need for classroom sponsors to get Juneau Empire in the classroom.

Book Group Resurrection – G. Brown: Looking for suggestions for when to meet and where to meet. Discussion. Suggested have meeting every other month; ask for co-chairs; target past members.

- Appoint Budget Committee C. Jebe motion, G. Brown second to appoint K. Andree, P. Watt and C. Jebe to Budget Committee, Motion passed.
- Appoint Bylaws Review Committee G. Brown made a motion, H. Barthel second to appoint M. Menzi and P. Watt to Bylaws Review Committee, Motion passed.

H. Barthel will ask the LWV Board if we can invite Mr. B. Mallott to be Lunch Speaker at Annual State LWV Convention. M. Menzi agreed to ask B. Mallott to speak at the State LWV convention coming in March 28, 2015.
