~ House sort of organizes-Senate rolling right along ~

HIGHLIGHTS

At long last, the House officially organized under Rep. Louise Stutes of Kodiak, 22-18. But, in a possible first, the duly elected Speaker still only has 20 votes she can count on - no working majority!

While (R) Rep. Merrick finally joined the multi-partisan coalition, (D) Rep. Tarr left after voting for the new organization. Tarr is the former Resources Co-Chair who caucused with the D's for eight years.

This time she'll be an independent D and said she was uncomfortable with all the power jockeying for leadership roles. Rep. Rasmussen also went maverick, voted for the Stutes team but will be an independent R.

Merrick is now Co-Chair of House Finance, along with Rep. Foster. Former Speaker Edgmon is Rules Chair; Rep. Tuck is Majority Leader; Freshman Rep. Patkotak will run Resources; Health & Social Services will be Co-Chaired by Rep. Zulkosky and newcomer Liz Snyder, Education Co-Chairs will be Drummond and Story. Tilton is the new Minority Leader.

Chief Justice Joe Bolger addressed the Legislature for the last time. He plans to retire in June. He said the court system has been "resilient" during the COVID challenge. They've done a good job complying with health requirements and still getting business done. Digital options made a huge difference.

Criminal jury trials have been the biggest problem since face-to-face proceedings are essential to proper justice but generally that hasn't been possible due to courtroom size and travel needs. Starting soon, Judges will have the option to hold jury trials in person.

Justice Bolger also opposed efforts by Senator Mike Shower and others to change the way we select district court and appellate judges. Bolger said our merit based, non-partisan system is the best in the US and there is no good reason to tinker with it. Critics say conservative candidates tend to get the short straw.

Juneau Superior Court **Judge Philip Pallenberg** has ruled for the Legislature and against the Governor. He found that 94 unconfirmed executive branch individuals served illegally between December 16 and January 18 after the legislative deadline for confirmation, including the Revenue Commissioner.

They were legally reappointed January 19. The Legislative Council didn't ask the court to undo actions taken during the co-called recess appointment period. This was a matter of principle regarding the constitutional allocation of power between branches.

BILLS On the Move

[SB 67](#), Nursing; Licensure; Interstate Compact sponsored by the Governor receives its' first hearing with invited testimony only. The bill allows Alaska to adopt the Multistate Nurse Licensure Compact. The Multistate Nurse Licensure Compact would allow Registered and Practical Nurses in any of the 34 participating states to practice in Alaska without being subject to Alaska's licensing process. It would also provide Alaska nurses with a multistate license to practice in the other 34 participating states.

The Compact would establish a commission with rulemaking, enforcement, and financial assessment provisions. Alaska would appoint one person to be the compact administrator within the state. The single-state and multi-state nurse licensing programs would have separate receipt support funding, which means the multistate licensing program will not impact the costs for the single-state licensees.

SB 67 would not affect Certified Nurse Aides (CNAs), Advanced Practice Registered Nurses (APRNs) or anyone else who wishes to practice under an Alaska-only nursing license.

It will be heard again on **Thursday** and *Public testimony will be taken*

[HJR 11](#) Waiver From Passenger Vessel Services Act, sponsored by Rep. McKay is similar to [SJR 9](#) sponsored by Sen. Kiehl. (SJR 9 moved from STRA last week and is now waiting a hearing in SL&C.) HJR 11 only urges Congress to pass legislation that provides a temporary waiver of the Passenger Vessel Services Act to allow cruise ships to sail directly to the state from other United States ports.

GOVERNOR'S CORNER

In spite of last minute pleas by the health care and business communities, Governor Dunleavy decided not to extend the COVID-19 Disaster Declaration. He said it's time to focus on recovery and issued a memo with "advisories". He called this a new beginning - to mixed reviews.

The Governor said they'd continue to operate as before, including state employee mitigation measures. Health care providers and local governments still worry about possible impacts.

Commissioners will closely examine and decide the fate of some 200 formerly suspended regulations that deal with everything from vaccination authority to telemedicine to curbside booze pickup.

Race against the variants. Thinking ahead, health officials also are worrying about coronavirus variants that are spreading around the globe and hope to speed up Alaska vaccinations. So far, 58% of Alaskans 65 or older have received a COVID 19 vaccine.

Governor Dunleavy told Senator Reinbold in writing that he's had it with her COVID 19 misinformation campaign and is done with the Senate Judiciary Committee. He said Reinbold was unethical and violated her oath of office.

Reinbold, who's been overly critical of the Administration's COVID policies and management, initially said Dunleavy was acting like a disgruntled legislator, not a Governor. Old-timer and former Senate President Gary Stevens said he'd never seen this kind of letter from a Governor.
