The Legislative Process Begins....

The Alaska Legislature gaveled in on Tuesday, January 17th. Both the House and the Senate have organized and announced majority and minority membership.

What to know this week

This week saw two meetings of interest: On Tuesday, the Alaskans for Better Elections along with data from Sightline (an independent research agency) on the 2022 elections were presented to the Senate State Affairs committee. Watch it here. There is some really good research information from Sightline on how RCV has increased competitiveness and actually made our elections look more like our voter preferences (thus making it more democratic - not less).

And, on Thursday the 26th, there was a <u>2022 elections recap</u> by the Division of Elections, including the topic on the challenge for rural voting. Michaela Thompson, Acting Division of Elections Director, reported on rejected mail-in and absentee ballots in 2022. Senators asked about the use of drop-boxes in the June Special Primary, and if they would be an alternative to Election Day polling places where there were difficulties finding poll workers. Thompson indicated that the drop boxes used in June were on loan from the Municipality of Anchorage. The state currently owns none. In regard to a ballot cure process, Chairman Kawaski indicated that the committee would be taking it up in the future. Michelle Macaur Sparck of Get Out the Native Vote, Cook Inlet Tribal Council, offered testimony about the challenges of running elections in remote locations. The problems with USPS delivery of equipment to villages and completed ballots to Juneau was also discussed.

All of the legislation we're tracking in the House has been referred first to the House State Affairs Committee. They didn't meet this week, so no updates as of this time. See the Calendar below for upcoming meetings.

The Lt. Governor has certified a petition from a group named "Alaskans for Honest Elections" who want to repeal Ranked Choice voting. And Kelly Tshibaka has created a group named "Preserve Democracy" also to repeal Ranked Choice voting as well. Watch for these.

Who's Who:

Senate:

The majority: Speaker: Sen. Gary Stevens (R-Kodiak) and majority leader Sen. Cathy Giessel (R-Anchorage). The Senate organized early and they are moving quickly. They have started weekly Press briefings as well. That may bring better transparency to the activities. All of the members except the three listed below are in the majority.

The remaining three: Sens. Mike Shower, (R-Wasilla); Robb Myers, (R-North Pole); and Shelley Hughes, (R-Palmer). Legislative rules don't recognize a minority caucus smaller than five members, so these three will not be guaranteed any seats on any committees, and there is no minority leader. As Sen. Shower has the majority of the pre-filed bills, and as he has no position on the majority, it is unclear as to whether we will need to focus on any of his bills at this time. We'll let you know. However, elections looks like it is going to be a hot topic anyway given the focus this week in the Senate State Affairs Committee.

Priorities: The majority outlined their priorities: Education, Retirement pension plan, how to deal with the PFD, and a focus on state resources (oil, mining, fisheries). One key is to not overdraw the PFD, the other is to do this without new taxes. The proposal from Gov. Dunleavy on carbon sequestration is interesting, and they will be looking at that. Sen. Kawasaki does have two bills (SB17-Campaign Contributions and SB19-Elections/Ballots), so those may move forward. Sen. Stevens has SB29-Civics Education which may also get hearings.

House:

The majority: The majority elected Rep. Cathy Tilton, R-Wasilla as speaker. Rep. Dan Saddler R-Eagle River is the Majority leader. This is a Republican-led majority, with the 4 "Bush Caucus" representatives - Reps. Edgmon (I-Dillingham), Foster (D-Nome), Patkotak (NA-Barrow), and McCormick (D-Bethel - joining making the total 23. Reps Edgmon and Foster are co-Chairs of Finance, so that is clear what they were looking for.

The minority: The minority leader is Rep. Calvin Schrage (NA-Anchorage). The minority is 15 members primarily Democratic and includes Rep. Ortiz (I-Ketchikan) who was previously in the majority. The minority has said their priorities include education funding, teacher retention, and funding state services at a "sufficient" level.

The rest: Rep. Eastman (R-Wasilla) is in a class alone, and Rep. Louise Stutes (R-Kodiak) has said she would like to join the majority but is not anywhere at this time, although she was assigned to the Transportation Committee.

Priorities: The majority has said that their priorities are "fiscal issues" but they haven't quite described what that means. Rep. Vance has been quoted saying that she is interested in repealing ranked choice voting, as well as legislation relating to "election security." Rep. Rauscher and Rep. Vance are both in the majority, and their bills are likely to be heard in committee. We'll be watching these. Although Rep. Schrage is in the minority, he also has a bill (SB37) related to Elections so he may get a hearing.

Governor's Office:

At the start of the session, the Governor made the rounds at the Legislature. He seems to be signalling a more collaborative working relationship with the Legislature this time. He has proposed raising revenue thru carbon sequestration. In his State of the State message, he focused on the carbon proposal, and he stated support for the families of Alaska in the "Healthy Families Initiative." It is unclear how he proposes to fund this, and if it goes far enough to help create jobs to keep people in state. For Commissioner of Corrections, Dunleavy has appointed Jen Winkelman as Commissioner-designee pending legislative confirmation.
