# This week: A focus on education, employee retention and judges

The House and the Senate are deep in Committee meetings. We have heard testimony centered around education in the Senate, a report from the retiring Chief Justice, and more on the State's budget.

#### What to know this week

On January 30th and on February 1st, the Senate Education committee heard many speakers giving testimony in support of an increased BSA (Base Student Allocation). They cited numerous reasons for increasing this allocation: teachers describing large class sizes, teacher salaries which have decreased, no teacher pensions and no ability for teachers to even pay into social security, the affects of inflation on costs including liability insurance, Alaska ranks 49th out of all 50 state in quality of eduction - this impacts whether families decide to stay in the state, it impacts whether students stay in the state after graduation, it impacts whether we can recruit teachers to the state, and so on.

However, not all testimony was in favor of increases. Some concerns with additional funding was that there isn't a lot of accountability on student outcomes, that "throwing more money" at the problem isn't a good solution, and that the State should cut administrative staff first in order to get more teachers.

The Senate Education Committee has now issued  $\underline{SB52}$  - an Increase in the Base Student Allocation . This would raise the BSA \$1,000. We'll be adding this bill to our tracking. This would be projected to raise the cost of the budget this year by \$247 million. The Governor's proposed budget included a PFD payment of \$3,860. Lowering the PFD to \$1300 would cover the cost of the increase.

In other news, Rep. Ben Carpenter (R-Nikiski) has hired Donna Arduin (now Donna Kauranen), former budget director for Gov. Dunleavy, to assist him with budget decisions. He is chair of the House Legislative Budget & Audit committee and the chair of the House Ways and Means Committee.

#### **National Issues:**

ERA NEWS: New joint resolutions on the ERA were announced in both the House and Senate this week. Senators Cardin and Murkowski, and Congresswomen Pressley, Bush, Spanberger, Dean, Garcia, and Kamlager-Dove, just introduced joint resolutions to affirm the validity of the Equal Rights Amendment and remove the arbitrary time limit from the preamble.

# **Alaska Legislative Updates**

#### Who's Who:

The AK Legislature has put out their contact list. You can view it here. One of our Juneau members, Gary Miller has also created a downloadable spreadsheet with contact information, it is posted on **VotingRightsAlaska.org** as well.

#### Senate:

**New Legislation:** Since the beginning of the session, the Senate has added 10 new bills, including SB40, SB41 and SB42 by Gov. Dunleavy on the operating, capital, and mental health budgets; and SB48 and SB49 also by Gov. Dunleavy on carbon offsets and how to dispose of them underground.

### House:

**New Legislation:** Since the beginning of the session, the House has added 13 new bills, including HB39, HB40, and HB41 by Gov. Dunleavy on the budget as well as HB49 and HB50 regarding carbon offsets. HB43 was introduced by Rep. Hannan (D-Juneau) prohibiting licensed health care workers from trying to change someone's sexual orientation or gender identity; and HB44 by Rep. Story (D-Juneau) for the schools to set up a curriculum to include local traditions and lifestyles.

These are listed just as an FYI, but we will not be specifically tracking any of these new bills in either the House or the Senate.

## **Governor's Office:**

The Commissioner of Labor, Tamika Ledbetter, unexpectedly resigned on Jan. 31st; Cathy Munoz (former Juneau legislator) has been appointed acting Commissioner. Corrections Commissioner Jen Winkelman testified on the number of in-custody deaths (18) saying 7 were suicides and the rest were 'natural causes.' She said many people imprisoned were in poor health but that the number is "unfortunate."

# **Judicial System:**

Alaska Chief Justice Daniel Winfree retired this month. In a <u>speech to the legislature</u>, he cautioned that we need to keep our current system of selecting judges which is outlined in our Alaska State Constitution. The following quote from his speech is worth noting:

"I recognize that some here don't believe in an independent judiciary but rather believe that Alaska's judges should be hand-picked and controlled by politicians so that the judges will render decisions that the politicians want. Our constitutional convention delegates were aware of that view and they expressly rejected it, along with rejecting the notion of elected judges and they did so in favor of the merit selection process we have in Alaska. The delegates wanted politics out of the judicial selection process all the way up to the governor's constitutionally authorized appointment of a judge from the list of the most-qualified applicants provided by the Alaska Judicial Council."

Sen. Mike Shower (R-Wasilla) and Rep. George Rauscher (R-Sutton) have both introduced legislation to change that (SB31 and HB34). Please consider contacting your legislators to ensure that these efforts don't move forward. The Senate may not hear this, but the House might, and it may be part of negotiations during the budget discussion.

At 3:30 pm, a meeting by the <u>Senate Education Committee</u> on the new Senate Bill 52 an increase to the Base Student Allocation including **public testimony**.

On Friday, Feb. 10th at 8:00 am, a meeting by the <u>House Education Committee</u>: Presentation: Strategic Reading Plan; Alaska Reading Playbook; Teacher Recruitment & Retention by the Dept. of Education. At 3:30 pm, a meeting by the <u>Senate Education Committee</u> on the new Senate Bill 52, and SB14 on a RIP for Public Employees/Teachers including <u>public testimony</u>.
