# Election Security, the BSA, and on to the Budget...

It has been a busy month so far at the State Capitol. It has never been more important than it is today, to focus on our Election processes.

## What to know: Meeting highlights week of March 6th and 13th

#### **Education related:**

On March 6th, the <u>House Education Committee</u> discussed the HB65 Base Student Allocation (BSA). Second hearing. Rep. Ortiz presented the impacts of inflation on our educational system. There were good questions raised on whether the legislators need to look at the way education is funded as the formula is complicated. On March 13th <u>House Education Committee</u> discussed HB 106 Teacher Recruitment - Lump Sum Payment. This had a fiscal note of \$51 million. Also at that meeting was an introduction to HB 105 Sex/Reproduction Education.

On March 14th, <u>Senate Finance heard SB 29</u> regarding Civics Education. Sen. Stevens presented this bill. He laid out the reasoning for the bill. The costs for this bill were outlined by Dept. of Education, and were almost a half a million dollars. Sen. Stevens requested the Dept. of Education rethink the fiscal note as he believed it was way more than warranted.

### **Ballots & Voting:**

On March 7th, the <u>Senate State Affairs</u> committee held a hearing on both SB1 (Voting Security) and SB19 (Elections, Ballots). SB19 was introduced by its sponsor - Sen. Kawasaki. This bill would have automatic renewal for absentee voting, a ballot tracking system, pre-paid return postage and a requirement for people to have the ability to correct a ballot if rejected. Former Rep. Chris Tuck also testified in support of this bill.

Sen. Shower presented his election bill SB1. While he testified that he wanted many of the same things as SB19, there was testimony which pointed out to wanting four things: to get rid of Ranked choice voting, get rid of the ERIC process, get rid of Dominion voting machines, and limit the time it takes count votes. They also want "outside review" of all election results - unclear as to who they would want. (See more of the testimony by the new Director of Elections — information below.)

#### **US Presidential Elections:**

On March 13th, the <u>Senate Judiciary Committee</u> discussed the US Presidential Election Popular Vote Compact. Sen. Wielechowski presented the bill. His POV was that this bill provides that every single voter in the US gets a say in the Presidential Election. All of the focus of the campaigns in recent history have focused on only certain states and the rest of the country is ignored. There was much testimony both for and against, and a number of people testified from out of state

### Carol Beecher on ERIC - Senate State Affairs Committee - March 9 - Submitted by Sue Sherif

The new Division of Elections Director Carole Beecher made state (ADN) and national news (Washington Post) when she testified to Senate State Affairs that she was considering withdrawing Alaska from ERIC, the nonprofit Electronic Registration Information Center, established to "improve the accuracy of America's voter rolls and increase access to registration" for all voters. An important part of its work is sharing information about voters who are registered to vote in more than one state, so that states can maintain more accurate voter rolls. Founded in 2012 and run and managed by the member states, 34 states and DC participated until recently when a few states have pulled out in moves that are seen as political statements. Beecher agreed that ERIC provided a service but cited economic reasons for considering withdrawal. Because membership dues are based on population, Alaska is in the lowest tier of dues.

A Juneau League member who was formerly on a statewide elections policy board, wrote this in response: "Regarding the concern about the cost of membership at \$17,000 a year, I'd say that is a bargain. It is much less than the cost of an employee(s) that would be needed to do the type of follow-up work with voter registrations. ERIC has very sophisticated, secure software to share voter roll data between states and provide those member states with up-to-date information. I [met] David Becker of ERIC when I served on [the] election policy committee and he was a knowledgeable, ethical person with a passion for fair and accurate elections." Becker, a leader and former board member of ERIC, has been accused of being an operative of George Soros. This Juneau member, who has years of experience in elections, writes further, "I would encourage the League and the Alaska Association of Municipal Clerks to support the State of Alaska maintaining its productive membership in ERIC, and encourage all of the other non-member states to join."

### National Issues Become Local Issues and Local Issues Become National....

#### From the LWV.ORG website:

"Pro-voter reforms have transformed our democracy and led to unprecedented voter turnout in the 2020 Election. But they are too often threatened by politicians and special interests who prioritize their own needs over an equal and fair democracy. When it comes to opposing these anti-voter efforts, the League is on the frontlines, advocating in state houses and in Congress, fighting anti-voter laws in court, and organizing activists to make their voices heard."

Don't be fooled, keep asking questions, and look at an issue from all sides and all research. Often, using the guise of election "security", it may result in just the opposite.

As you watch and listen to our legislators, and to testimony in the Alaskan House and Senate, try to assess whether their actions and words are truly for the 'good of the State' or if they are indicative of a special interest. The less secure and non-partisan the election system is, for instance, the more open it is to manipulation from outside interests.

## DID YOU KNOW? Arctic Village Council v. Fenumiai

LWV of Alaska and its co-plaintiffs filed a lawsuit in Alaska state court, asserting that the lack of a notice and cure process for errors on absentee ballots violated the Alaska Constitution's guarantees of the right to vote and procedural due process. The State has filed for a dismissal of the case, but the case is ongoing. To read more on this see: **Arctic Village Council v. Fenumiai**.

The Governor submitted two new bills of interest regarding education (referenced above): HB105, Teacher Recruitment - Lump Sum Payment, and HB106, Sex/Reproduction Education with companion bills in the Senate: SB96, and SB97.

## **Judicial System:**

We have added HB 82 to our watchlist of legislation (see above).
