## Rushing to finish?

Session ends on May 17th this year, and things are moving quickly. Quite a bit of legislation is moving onto the floor to either pass or not. At least a dozen bills we are tracking are moving out of committees or holding hearings and none of our tracked bills have moved either out of the House or Senate. But we'll be watching. Bottom line - the big focus is on the budget and the PFD,.

## What to know: Heading into May

#### The LWV Alaska State Convention was held April 22nd with an impressive set of speakers!

Both of our Senators were invited, as well as Rep. Peltola. Sen. Murkowski sent an impassioned recorded plea for us to help support the Equal Rights Amendment in the Senate. (Unfortunately, it didn't pass yet again). Rep. Peltola was in Juneau speaking at the totem raising and couldn't attend, but her chief of staff Anton McParland filled in for her. He was an amazing speaker. He talked about being impressed by a presentation from the League in his home state of Nevada, and he joined the League at the age of 19. So a great supporter to have in Rep. Peltola's office. He spoke about the political divides in Congress, and or Rep. Peltola's approach in trying to find common ground, and to maintain a level of civility in DC. We also heard from our Alaskan Sen. Kawasaki (Fairbanks) and Rep. Schrage (Anchorage) who introduced us to his new baby. They spoke on the election bills in the Alaskan legislature and the need for testimony and letters. Finally, we heard from Ruth Botstein, ACLU Alaska Legal Director and Kendra Kloster, Co-Director, Law and Policy, Alaska Native Women's Resource Center. Both spoke passionately about ensuring that everyone in Alaska has the right to vote, and how we can help. The hybrid 'zoom' allowed members from each city to meet in person, as well as join with others on Zoom.

### Highlights from last week:

A couple of new bills were introduced: HB 165 CHARTER SCHOOLS; CORRESPONDENCE PROGRAMS sponsored by the House Ways & Means Committee led by Rep. Carpenter (R-Nikiski) and SB 138 ELECTIONS; VOTER REG.; CAMPAIGNS (**Public Testimony**) sponsored by the Senate State Affairs Committee led by Sen. Kawasaki (D-Fairbanks). ### **Legislative Calendar and Events**

#### Calendar:

May 17th - 121st day of the session (Per the Alaska Constitution)

It is possible that the session *may* go into a special session, depending on budget negotiations. The Senate is expected to take up the Operating budget towards the end of the week of May 1st. When passed it will go back to the House (likely the week of May 8th) - where the House can accept it or they can go into a conference committee to resolve differences. Starting May 12th (until session end) they will go into a 24 hour rule where bills that have been heard may move very quickly.
