The Legislature has a law that says they need to end after 90 days (AS 24.05.150), however, every year they ignore it and aim for the Constitutional limit of 120 days, ending May 17th. So, there is just about one month until the end of session. Things will start moving quickly now—we'll try to keep up. Another Awesome "Lunch With the League": (April 14th)

If you haven't attended one of the new *Lunch with the League* Zooms yet, you are missing out! The latest Zoom had former Representative Chris Tuck discussing the current Elections bills and processes.

He outlined his efforts to pass election reforms over the last few legislative sessions. He spoke about trying to get some level of election reform passed this year. He also raised some concerns about the state's use of ERIC, a rather surprising opinion, but based in his concern over a centralized database of all people in the country and how to keep that safe.

He believes that there is going to be an effort in the Senate to take the existing election bills and create a new elections bill with more bi-partisan support. We'll be watching to see if that happens in time. He didn't believe anything would pass regarding the Houses' effort to eliminate the Dominion voting machines due to pending litigation and cost, but pieces of the other House legislation would likely be found in other pending legislation.

When he was asked what the League should be doing he said, "Educate, advocate and organize." Educate so you communicate with everyone, find common ground and then build relationships. As you reach people, you can then advocate for change. And, finally, organize members to increase our efforts and our voice.

PUBLIC TESTIMONY: A big focus this year is on the Alaska State Budget. The debate so far has been centered around education funding vs. the PFD. As with all budgets, the question is how to balance the competing needs and wants. So there will be multiple sessions for public testimony - make your voices heard (next page for details...)
