

How will our budget crisis affect education?

The Alaskan economy is taking a hit.

This is the week that the Senate tries to have a budget prepared for discussion. We'll see if that happens. Last week, by a 21-19 vote, the House passed [House Bill 56](#) Approp: Supplemental. This is a "fast-track" Supplemental budget bill designed to address the shortcomings in the current fiscal year, which ends June 30. There isn't enough money to cover this almost \$200 million dollar bill without drawing from the Constitutional Budget Reserve funds. This is \$111 million in unanticipated expenditures and an \$80 million shortfall based on the price of oil. The vote to withdraw funds needs a two-thirds majority and that measure failed 21-19. The bill now goes to the Senate, where they will add it to the agenda in Senate Finance.

This means that the focus of the legislature now moves headlong into budget discussions. The two major bills we have been focused on are now converging in Senate Finance where they will be considered along with their budget impacts.

The fate of the education bill [HB69 \(Education Funding: Increase BSA\)](#), (which is now CSHB 69(RLS) AM - the committee substitute for HB69) is in the Senate Finance Committee. This bill, along with the Supplemental budget, the PFD payout, and all of the other funding requests, will be up for discussion. With Alaska facing lower oil prices, federal government cuts, stock market turmoil, the deficit from last year and no consensus in the House on how to raise any revenue, it is a difficult time ahead.

[SB64 \(Elections\)](#) was approved in Senate State Affairs on March 27th and moved to Senate Finance where it will be heard on April 9th. There was still a bit of confusion on some of the technical language within this bill, so there might still yet be some amendments before it moves forward. This will likely be one of the last times there will be public testimony on this bill in the Senate before it would move to the House.

So for all Alaskans concerned about our state, our government services, our ability and access to voting, and our PFD, the Senate Finance Committee is the place to watch with meetings every day next week.

Recap of the All-Alaska LWV Virtual Town Hall.

On Thursday, March 27th, former Senator Mark Begich and Alex Ortiz (former chief of staff to Congressman Young and Congresswoman Peltola), discussed how to effectively make our voices heard in Congress. Some key takeaways: find places where you can agree with what the Senators/Representative are doing; be polite and offer help or guidance on how to change something; write a personal note on what it means to you directly don't just rely on 'form letters/emails'.

Legislation Tracking

There was a hearing on [HB98 Maximum Pupil-Teacher Ratio](#) on March 28th. Rep. Fields explained why the current PTR (Pupil-Teacher Ratio) is the wrong metric when looking at actual class sizes. Most parents know this. Alaska's PTR is 18; while some actual class sizes could be close 35. This bill uses actual class size (not PTR) to set maximum numbers of students in each class. As it is currently worded, this bill only affects Anchorage schools, but could be used elsewhere if there is interest.

This was a great conversation about the impact of class size on student success, plus some really interesting documents that dig into the details. [Watch it here](#) if you're interested in the details.
